### **REPORT**

Central Tablelands Water has received a sponsorship proposal for the 2022 Henry Lawson Festival at Grenfell.

The Henry Lawson Festival is a major event for the town of Grenfell. The Festival is held on an annual basis over the Long Weekend in June. The Festival has been running for 65 years and is seen as one of the oldest rural festivals still operating in NSW.

Council in the past has contributed \$250 towards the Henry Lawson Festival, apart from the last 2 years whereby the Festival was not held due to COVID-19.

As this unique rural festival helps strengthen the Weddin Shire economy and like many rural events contributes to regional tourism, the general manager is recommending that Council continue to support this community event by contributing \$250.



## Introduction

The Henry Lawson Festival is a major event for the town of Grenfell. Located in the Central West of NSW. It is held annually over the Long Weekend in June over four days. It has been running for 65 years and is seen as one of the oldest rural festivals stills operating in NSW.

This is the 63rd Henry Lawson Festival and it's been 65 years since the first Festival making it one of the longest running Arts Festivals in NSW. In 2022 we are looking forward to building on the strong history and success of past Festivals. This years' program is full of new elements and traditional favourites. The program will showcase Grenfell, celebrate Henry Lawson and provide a variety of arts focused entertainment for all who attend. This year's theme is '100 not Out – The Legend Lives On' which celebrates and acknowledges that it has been 100 years since Henry passed away.

#### **REPORT**

As presented at the Central Tablelands Water (CTW) Integrated Planning & Reporting (IP&R) workshop in February 2022, the *Local Government Act 1993* requires all councils including county councils to prepare IP&R plans under an IP&R Framework. The purpose of the inter-related suite of IP&R plans is to:

- Ensure the long-term sustainability of council;
- Provide increased transparency and accountability;
- Guide council in all that they do;
- Provide an evidence base for all decisions:
- · Provide regular opportunities for monitoring and review, and
- Demonstrate how services are to be delivered; asset investments and other decisions are made, addressing long-term goals and objectives of the council and stakeholders.

Section 219 of the Local Government (General) Regulation 2021 requires county councils to develop and endorse a Business Activity Strategic Plan (BASP) that identifies the main business activity priorities for the Council covering a period of at least 10 years. The BASP also outlines established strategic objectives together with strategies for achieving those objectives, and is to be developed having due regard to the community strategic plans of the county council's constituent councils.

Section 403 of the *Local Government Act 1993* requires the establishment of a long-term resourcing strategy for the provision of resources required to implement the strategies established in the BASP. The resourcing strategy consists of a long-term financial plan, workforce management plan and asset management plan.

Section 404 of the *Local Government Act 1993* requires the establishment of a new 4 year delivery program after each ordinary election. The program details the principal activities to be undertaken by the council to perform its functions (including implementing the strategies set out in the BASP) within the resources available under the resourcing strategy.

Section 405 of the *Local Government Act 1993* requires the establishment of a new operational plan that details Council's activities and budget for the next 12 months.

In preparing to meet the above legislative requirements, CTW's Senior Management Team, Managers and Asset Officer have completed a significant amount of work to review and update the suite of draft plans. This has also included holding IP&R and strategic workshops with staff, councillors and constituent councils. CTW has engaged with its constituent council members to ensure that CTW's BASP has been developed having due regard to the community strategic plans of the constituent councils and the strategic regional priorities of the Central NSW Joint Organisation relevant to CTW's operations or functions.

In accordance with legislative requirements the following draft documents are now presented for Council's consideration prior to being placed on public exhibition:

- Business Activity Strategic Plan
- Delivery Program
- Operational Plan
- Workforce Management Plan
- Asset Management Plan
- Long Term Financial Plan.

Due to the large size of the draft Plans, they are to be issued directly to all Councillors and therefore are not attached to this report.
